## RETRACTION AND APOLOGY

On the 18th day of October 2019, the High Court presided over by her Ladyship Georgina Mensah-Datsa entered Judgment in favour of Mr. Ibrahim Mahama (Plaintiff/Judgment Creditor) against myself and Despite Group of Companies Ltd (the Defendants/Judgement Debtors) and the following orders were made against the Judgements Debtors jointly and severally;

- An order directed at the 1st Defendant, compelling him to publish in the Daily Graphic and on UTV an unqualified apology to the Plaintiff and a retraction of the said statements with the same prominence as the defamatory statement;
- An order compelling 2<sup>nd</sup> Defendant to remove from its archives, be it electronic or of whatever form, the said defamatory statements;
- Damages of Three Hundred Thousand Ghana Cedis[GH300,000.00];
- Cost of Ten Thousand Ghana Cedis [GH10,000.00];

That in furtherance and in fulfilment of the above Court Order (i), I Ernest Owusu Bempah on this 2nd day of February, 2021 state as follows that:

- While partaking in a political discussion on UTV's "Adekye Nsoroma" morning show on the 3<sup>rd</sup> of March, 2018, I made the statement that "... because krono na w'abo, krono na w'abo" to wit 'he (Ibrahim Mahama) has stolen';
- By the said statement I made I published to the world at large that Mr. Ibrahim Mahama has stolen and that he Mr. Ibrahim Mahama is rich or wealthy because he has stolen.
- The statement which I made then was made without any basis and was made without due regard to the hard earned reputation of Mr. Ibrahim Mahama and I ought not to have made same.
- 4. That the statement I made about Mr. Ibrahim Mahama was not true then and is not true now and can never be true and that I had no reason to make that statement.
- Irrespective of how it happened, the fact remains that I should never have made such a statement of Mr. Ibrahim Mahama. The statement was clearly

- 6. I sincerely and humbly apologize to Mr. Ibrahim Mahama for my unjustified and unfortunate statement about him. I am sincerely sorry and humbly ask for his forgiveness and I also apologize to his family and all persons who were affected by my denigration of the person and standing of Mr. Ibrahim Mahama in society.
- I further render an unqualified apology to Mr. Ibrahim Mahama and his business associates who have been affected by my statements.
- 8. Prior to the issuance of this statement, I called Mr. Ibrahim Mahama on phone to render an unqualified apology to him and to my surprise he received me warmly as a brother and referred to me as a younger brother and even invited me to his home. These acts of his make me regret more my conduct and I say without reservation that I am sincerely sorry for what is aid about him.
- I hereby unreservedly apologize for the statement I made and accordingly retract the statement I made about Mr. Ibrahim Mahama on the 3<sup>rd</sup> of March 2018 for which reason the Court gave judgment against me.

That the above retraction and apology is made by me without any reservation or qualification.
