DEAL WITH THESE IRREGULARITIES!

he Auditor General's Report released recently about tax irregularities, payroll fraud and other malpractices at the government ministries, departments and agencies including the metropolitan, municipal and district assemblies is most disheartening.

Some of these irregularities have always attracted media attention because of how the nation often loses moneys which could have been used to address some developmental challenges.

For instance the issue of payroll fraud has been a major concern over the years necessitating the introduction of the electronic payment system for public sector workers.

The Controller General's Department also in a bid to stop these malpractices introduced the verification system for government workers before salaries are

It is therefore most surprising that we continue to record cases of payroll fraud despite all these stopgap measures introduced over the years.

Clearly, the identification and prosecution of these individuals behind this fraudulent practice most of who are public servants is long overdue.

Institutions such as the Economic and Organized Crime Office and the Financial Intelligence Centre need to team up with other state agencies such as the Office of the Special Prosecutor and that of the Auditor General to ensure the prosecution of these criminal gangs and thieves instead of the existing arrangement of reporting and surcharging offenders if this nationwrecking practice is to grind to a halt.

There is no denying the fact that the 'soft' handling of these 'thieves' behind the 'ghost names' is what has emboldened them and made their exorcism difficult.

"I advocate that we rather go the Caribbean and Latin

American way where those who can afford to pay for all or part of their education do so; proceeds from, which can then be used to support those who really are needy.

"At least those who can afford it ought to pay for the feeding of their wards in boarding schools.

Blanket free-feeding of all children is more likely to result in malnutrition," Prof. Addae-Mensah said.

The Free SHS policy is Government's flagship education policy, which commenced in 2017 as a policy intervention to ensure that every Ghanaian irrespective of their background have access to free secondary education.

Under the Programme, beneficiaries are provided with free tuition, accommodation, and feeding.

Prof. Addae-Mensah stressed that the "blanket" provision of Free SHS could lead to large enrolment, adding that if adequate resources and facilities were not provided, standards could drop to the detriment of those who could not afford to enrol their wards in private schools

He said Ghana's first President, Dr Kwame Nkrumah preferred free education up to the secondary level but "he was pragmatic enough not to introduce it at the time that he was in power."

"...If there is blanket provision of free education for everybody, and there is resultant increase in enrolment, there is the likelihood of population explosion, which not properly handled can result in significant lowering of standards due to inadequate facilities, teaching, and poor teacher motivation," Prof. Addae-Mensah said.

Court Dismisses Petition Challenging Nationality Of Jomoro MP

n election petition case against the Member of Parliament for the Jomoro constituency, Dorcas Affo-Toffey, has been struck out by the Sekondi high court. This comes after a citizen, Joshua Emuah Kofie, went to court to challenge the eligibility of the MP to contest as a representative of the people in the constituency on the ticket of the National Democratic

Congress (NDC) on grounds that she had multiple nationalities, including American and Ivorian citizenships, which is against the 1992 Constitution.
The Sekondi High Court presided over by Justice Dr. Richmond Osei Hwere dismissed the case on grounds that the MP was eligible to contest as she lost her Ivorian citizenship at the very time, she acquired her Ghanaian citizenship.

In regards to her American citizenship, the MP denied having American citizenship. The case has been in court for over 20 months since she was elected to represent the people of Jomoro constituency.

Speaker Says Doctors Working In Hospitals Without Being Paid Worrying

he Speaker of Parliament, Alban Bagbin has bemoaned the failure of the government to give financial clearance to some medical doctors who have completed their housemanship. Speaking on the floor of Parliament on Thursday, November 18, 2022, the speaker said that he has come across doctors working in government hospitals without pay. He added that because of the poor working conditions of health professionals in Ghana, including nurses and doctors, many of them are now leaving the country for greener pastures abroad.

"One and a half weeks ago, I met my colleague Speaker of Parliament of Barbados and he informed me that between last year and this year they were

able to recruit 400 nurses ... I meet some in Canada (medical officers) who told me, they are no longer interested in returning because of the lack of tools in our health facilities. "... a few years ago, we had what we call brain gain, health personnel were returning to the country to work because things had greatly improved. I think the substance has gone down and you will have to sit up.

"It is a very serious matter, as of now, I know a number of district hospitals being manned by doctors who are not being paid. The new doctors that you are talking about financial clearance, they are unemployed and they have just volunteered to go to those district hospitals just to work

for free. So, it is an urgent matter," he said.
Speaker Bagbin urged the Minister of Health, Kwaku Agyeman-Manu, to engage the Public Services
Commission of Ghana to help resolve the challenge of getting financial clearance for doctors who have completed their housemanship.

Massive Anti-Imperialist Rallies In Greece Commemorate Athens Polytechnic Uprising Of 1973

eople across Greece last Thursday marked the 49th anniversary of the Athens Polytechnic uprising of 1973 by organizing massive antiimperialist demonstrations. Tens of thousands of people, including members of the Communist Party of Greece (KKE), Communist Youth of Greece (KNE), All Workers Militant Front (PAME), Students' Struggle Front (MAS), and Hellenic Committee for International Detente and Peace (EEDYE), among others, marched in Athens and other cities. The marchers paid tribute to the fallen victims of the police repression of those who rose up against the US-backed right-wing military junta ruling Greece at the time. In Athens, demonstrators marched to the American embassy, chanting anti-imperialist slogans and raising banners against US imperialism and NATO expansionism.

The Athens Polytechnic uprising began on November 14, 1973 as a student strike which escalated

into a massive demonstration of popular rejection of the ruling Greek military junta (1967-74). The open anti-junta revolt ended in bloodshed in the early morning of November 17 after a series of events, starting with a tank crashing through the gates of Athens Polytechnic. Around 40 students were killed by the security forces. Diomidis Komninos (1956-1973), a high school student, was the first casualty of the uprising. He was shot opposite the main gate of the Polytechnic. The uprising marked the beginning of the end of the Greek military junta rule and is hailed as a symbol of resistance to tyranny. KKE General Secretary Dimitris Koutsoumbas said on Tuesday, "The events and marches 49 years later show that the messages of the Polytechnic

uprising-such as 'out with the US and NATO, the bases of death'... against poverty and unemployment, for public and free education and health, against state repression, fascism, eavesdropping and surveillance that is, the very dictatorship of capital - they are still relevant, timeless and alive to this day." The Students' Struggle Front asserted in a statement that "the heroic legacy of the Polytechnic Uprising 'arms' our fight against the state repression that accompanies the anti-grassroots policy [and] the anti-educational laws passed by governments." KNE stated that "At the Polytechnic, the people spoke. Imperialism is not invincible!" Meanwhile, the conservative New Democracy (ND)-led government in Greece has started the deployment of the **University Institutions Protection**



ended in bloodshed in the early morning of November 17 following a series of events that started with a tank crashing through the gates of the Polytechnic

Teams (OPPI), aka 'University Police', in major universities in the country and has increased the surveillance of academic spaces. This has triggered widespread protests among student and youth groups who have slammed the

militarization of campuses as an attempt to thwart radical mobilizations against the antipeople policies of the government.

Netanyahu And Itamar Ben Gvir Agree To Legalize Outposts. What Does It Mean For Palestinians?

ncoming Israeli Prime Minister Benjamin Netanyahu on Thursday agreed to right-wing leader Itamar Ben Gvir's proposal to carry out retrospective legalization of outposts in the occupied territories within 60 days of coming to power. Netanyahu's Likud-led alliance won a decisive majority in the Israeli elections held on November 1 and he has been tasked by President Isaac Herzog with forming the next government. Ben Gvir is a key member of the coalition.

The decision was announced after a meeting between Netanyahu and Ben Gvir finalizing the formation of the government.

Outposts are smaller settlements mostly erected on Palestinian land in the occupied territories. They are usually built near existing settlements. There are over 700,000 Israelis living in over 250 settlements and over 100 outposts in the occupied Palestinian

territories (OPTs). Though both settlements and outposts are illegal according to the international law on occupied territories, Israeli laws recognize settlements but consider outposts illegal.

Netanyahu and Ben Gvir also announced the decision to amend a 2005 law to legalize the Homesh and Yeshiva outposts in the occupied West Bank. The Homesh outpost is located on highway 60 used by both Palestinians and settlers and its legalization may further restrict the movement of Palestinians. An existing settlement there was dismantled by the Israeli state according to a law passed in 2005 under then-Prime Minister Ariel Sharon's "disengagement plan." It is now an Israeli military base. While Israel officially considers outposts to be illegal, observers have pointed out that settlers there are provided full security and financial assistance by the Israeli government. The residents of the outposts have

the same rights as any Israeli citizen. The legalization of outposts will create further troubles for Palestinians, who are already facing obstacles with regard to their freedom of movement due to the apartheid walls, settlers-only roads, and numerous check points created to maintain the segregation between them and the illegal settlers. Earlier this week, Benny Gantz, defense minister in the outgoing Yair Lapid government, announced the expansion of the apartheid wall in the OPTs by another 100 kilometers. The hundreds of kilometers-long wall was erected in 2001 in order to separate Palestinian residential areas and illegal settlements.

Due to the apartheid wall and other segregation measures, along with the existence of separate legal provisions for settlers and occupied Palestinians who live in the same area. international and Palestinian human rights groups have called Israel an apartheid regime.

Complete violation of UN resolution

and international law

Despite the objections periodically raised by the UN and other countries, Israel has aggressively pursued the expansion of illegal settlements inside the OPTs. In 2016, the UN Security Council adopted resolution 2334 which asks Israel to end the expansion of settlements, calling them a "flagrant violation of international

However, Israel has continuously expanded illegal settlements. Netanyahu in 2019 announced a plan to annex a large part of the occupied West Bank where illegal settlements have been built. He failed to implement the plan at the time due to his election defeat and fierce Palestinian opposition. The decision to legalize the outposts has long been supported by Ben Gvir and other extremists in Israel. Ben Gvir is himself a settler from Hebron in the southern occupied West Bank. He

also shares an ideological affinity with Hilltop Youth, a terrorist settler group involved in several attacks and killings targeting Palestinians with the intention of expelling them from the OPTs and expanding the settlements.

The Palestinian Authority (PA) issued a formal statement opposing the move to legalize the outposts. It appealed to the world community to intervene to scrap the agreement. Presidential spokesperson Nabil Abu Rudeineh said the deal would "deepen the settlements and lead to the confiscation of more Palestinian land." He also said that this will undermine "any possibility of achieving peace and establishing an independent Palestinian state on the basis of a two-state solution and in accordance with the UN resolution."

social entrepreneur deeply involved in Ghana's agricultural sector, and who has suffered unjustifiably in the hands of institutions and people manning Ghana's Agricultural value chain, has decided to put the issues into proper perspectives for government's action.

He says, indigenous lawyers, local banks, are constantly conniving insidiously to milk the country's Agricultural sector dry, hence the weak performance of the Agriculture sector in the country.

In short, Issa Ouedraogo, the founder of B-BOVID, who has gone through hell in the hands of the aforementioned in the last 17 years, claims, until Government of Ghana identifies these abnormalities silently creating an avoidable lacuna along the value chain of the Agricultural sector, and stem the tide, nothing significant would be achieved whilst the pockets of individuals fronting for fake foreign investors as lawyers, and banks would continue to get full.

These irresponsible local banks, he stressed would continue to whitewash the surface of the fiscal policy regime and beneath their activities, they would continue to connive with fake foreign investors to shortchange the country in various ways.

Addressing participants at Ghana social enterprise forum organized on Friday at the British Council under the theme: 'Partnerships for sustainable development: social enterprises as catalysts for inclusive growth in Ghana,' an angry Issa Ouedraogo, who has had terrible experience and practical issues with all the aforementioned in the last 17 years, while dealing with them, pointed out that foreign direct investment into Ghana's Agricultural sector appears good in the books, but lacks clarity, conformity, and integrity.

He cited his personal engagement with one French organization which came into the country as social impact investors and cunningly took over his company he personally struggled to birth in the last two

decades with his sweat and toil without the support of any government institution.
He said government must consider investigating the modus operandi of some of these firms to ascertain if indeed these companies are decent enough and do not hold Ghana sway in its underhand dealings with local and foreign partners.

He again cited two banks, one for fraudulently engaging in unprofessional conduct to assist investors to cheat, and milk the Agricultural sector dry.

He said they denied him and others value for interest free facility acquired.

In the case of one of the banks, he said he negotiated with a bank in Sudan for an interest free facility which had to pass through them but eventually the loan was given to him by the bank at a cut throat interest rate at the blind side of central government.

This issue, he said must not be swept under carpet, and that government must cause serious investigation into some of these issues.

He said the said bank fabricated a very bad story about him, and defamed him completely before many dignitaries in this country and also published falsehood about his company nationally and internationally. For another bank, he claimed the Bank unprofessionally got misguided to engage in illegal tampering of accounts, approval of transactions at his blind side with an account he jointly owned with another company. In his quest to promote periurban farming, the social enterprise entrepreneur, initiated in 2012 the Ghana Peri-urban Vegetables Value Chain Project (GPVVCP), which is a subsidiary project under GCAP being funded by a grant of US\$2.85 million from the Japan Social Development Fund (JSDF) through a Trust Fund

Bank.

Unfortunately, his company was eliminated at the implementation stage in 2017 with an excuse that the company never showed interest.

The project is being implemented by the Ministry of Food and Agriculture.

In his attempt to fight for justice in the law courts as he exposed the double standard of a company pretending to engage in social entrepreneurship which culminated in the partnership with his company B-BOVID, he said Ghanaian lawyers working in the cover of darkness for monetization of justice, then jumped to the defense of the said company obviously sending a wrong signal out there that the justice system of the country was for the highest bidder where crooks could maneuver and manipulate their way through, once they had money. All these negative developments,

he underscored, would continue to work impervious against the Agricultural sector and ultimately

REQUEST FOR ACTION

I am a Ghanaian and a card bearing member of the National Democratic Congress with membership number E330260030 in good standing, and a supporter of Mr. Johnson Asiedu Nketia (General), a contestant for the National Chairman position of the National Democratic Congress.

I write in reference to the Council of Elders' release dated October 26th, 2022, with reference number NDC/HQ/VOL2/07, with focus on paragraph five which reads; '...the use of decorous language, refrain from media attacks, breach of c o n f i d e n t i a l i t i e s a n d misrepresentations of decisions taken in relation to past actions of leadership."

I am by this letter bringing to your attention that, the National Chairman's campaign camp is in serious breach of this directive.

First, Koku Anyidoho, a suspended

member of the party, is persistently attacking the person of Mr. Asiedu Nketia, alleging that, his suspension from the party was a unilateral decision by the General Secretary.

I respectfully request of the Council of Elders to issue a statement on the said decision and stating as to whether or not it was a collective decision or a unilateral one as claimed by Mr. Anyidoho. Again, I want Chairman Ampofo as the leader of the Party to publicly state his position on Anyidoho's suspension.

These, in my estimation, will restrain the supporters of Aseidu Nketiah from coming out to explain what transpired at the Functional Executive Council (FEC) meeting that led to Koku's suspension. For if it persists, we shall be forced to do whatever we can to defend Aseidu Nketiah with evidence to clear his name.

Someone might be tempted to argue that Chairman Ampofo knows nothing about what Koku Ayindoho is doing. But I hold a contrary view. And here is my reason.

Presidential Candidate Donald Trump Wants To "Lift Up" Workers. Here's What He Actually Did In Power

n Tuesday, November 15, speaking from his Mar-a-Lago estate in Florida, former US President Donald Trump announced his candidacy for the 2024 presidential elections. This announcement comes at a time when the former right-wing president, whose policies championed the wealthiest, is actively being dropped by the wealthy, conservative leadership of the US

Trump's devastation of the working class

At many points in his announcement speech, Trump positioned himself as the candidate of the US working class. In reality, as a billionaire real estate mogul himself and a promoter of policies catered towards the ultra-rich, Trump could not be more out of touch with working people. "We will fight with every measure of our strength and with every ounce of our energy," Trump proclaimed. "To lift up the working men and working women of

As president, Trump implemented massive tax cuts for the wealthy in 2017, allowing many billionaires and corporations to pay lower taxes than working people. These "reforms" effectively transferred \$2 trillion from workers to the ultra-

America and to restore the fabric of

this nation."

The National Labor Relations Board (NLRB) enforces labor law but has been historically skewed towards the bosses. Trump <u>further</u> <u>weakened worker protections</u> by overturning NLRB precedent to favor bosses, restricting where workers can organize and protest, among other policies.

Trump crusaded against raising the federal minimum wage from \$7.25 to \$15 per hour. He made over eight million workers ineligible for overtime pay, costing them a total of \$1 billion in stolen wages per year. Trump's wave of deregulation made it easier for corporations to pollute the water and air. Soon after taking office he signed an executive order mandating that for every one regulation implemented, two must

be revoked. Trump also slashed Occupational Safety and Health Administration (OSHA) resources, reducing the number of inspectors to an all-time low, depriving workers of needed job safety personnel.

"To every worker and family

struggling to survive in the Biden

economy with inflation destroying your family and your life, this campaign will be for you," Trump said on Tuesday. Trump's presidency was also characterized by his genocidal handling of the COVID-19 pandemic, making the United States the unquestionable leader in terms of COVID-19 deaths at over one million. Trump had allegedly been made aware of the pandemic's deadly nature as early as February 2020. At the same time, Trump's administration was pursuing public health budget cuts, including a 15% cut to the Centers for Disease Control and Prevention (CDC) which equaled \$1.2 billion. Under his presidency, the CDC could not even prepare a proper COVID-19 test kit two months into the pandemic. Trump's abject failure in distributing tests and PPE and providing incentives for workers to stay home and protect themselves against the disease, among other measures, devastated the US economy as infections and deaths skyrocketed far beyond all other countries in the world. All while Trump himself downplayed the seriousness of the virus, fueling a nationwide anti-public health movement that continues to plague the country. And yet, Trump opened his announcement on Tuesday by boasting about how well-off the people of the US were under his presidency. "Two years ago, when I left office, the United States stood ready for its golden age," Trump speechified. "In four short years everybody was doing great, men, women, African-Americans, Asian-Americans, Hispanic-Americans, everybody was thriving like never before." At the height of the pandemic in April 2020, the unemployment

rate was 14.8%, the highest it has ever been since this statistic was first reported in 1948. Black and Latino people experienced even higher unemployment rates. Black, Latino, and Indigenous people also died of COVID-19 at a disproportionate rate as compared to white people in the US.

Ultra-wealthy dump Trump?

Despite the fact that Trump has been nothing if not a faithful champion of the wealthy and powerful through his policies, it seems that a subset of the wealthy Republican donor class no longer favors him as a candidate.

In the November 8 midterms, Trump's own Republican Party performed below expectations and most Trump-endorsed candidates failed to get elected. Shortly afterwards, the Wall Street Journal, a conservative corporate media outlet owned by multibillionaire Rupert Murdoch, published an editorial advocating for an abandonment of Trump. "Mr. Trump had policy successes as President, including tax cuts and deregulation, but he has led Republicans into one political fiasco after another," wrote the Wall Street Journal editorial board. "Maybe by now

Republicans are sick and tired of losing."

Incumbent Florida Governor Ron DeSantis, once a staunch Trump ally, who has carried out extreme right anti-LGBT, antidemocracy, anti-immigrant, and racist policies, made one of the strongest showings during the midterm elections, winning by nearly 20 percentage points. As a result of his victory, many believe that he is favored to run against Trump in the 2024 Republican Party primary. Trump slammed DeSantis postmidterms in a thread on Truth Social, an alternative social media site that Trump has been relegated to following his ban on Twitter.

"And now, Ron DeSanctimonious is playing games!" denounced Trump. "The Fake News asks him if he's going to run if President Trump runs, and he says, 'I'm only focused on the Governor's race, I'm not looking into the future.' Well, in terms of loyalty and class, that's really not the right answer." DeSantis responded to these comments on Tuesday. "All that's just noise," he said. "And you know, at the end of the day, I would just tell people to check out the scoreboard last Tuesday night," he said, referring to his own win.

DeSantis also responded to the

inadequate performance of many Republican candidates at the polls. In an implied reference to Trump's endorsed candidates on Tuesday, DeSantis said, "There were a lot, a lot of disappointments...That's just the reality. It was a hugely underwhelming, disappointing performance, especially given that Biden's policies are overwhelmingly unpopular." Trump remains popular with Republican voters, with an 80% approval rating according to FiveThirtyEight, although this has declined from 91% since election day in 2020. According to Pew Research, Trump's popularity has dropped among Republicans since 2016. Pew Research also found that while a majority of Republican voters want Trump to stay in politics, most do not want him to run for president.

Counting the 2018 midterms, the 2020 election against Biden, and now the 2022 midterms, some in the Republican leadership have soured on Trump, who has delivered them three bad elections in a row. Will divisions continue to form within the US ultra-right? Time will tell.
