show that Ghana will be meeting the Board even by May 24 as claimed by officials.

It would be recalled that Minister of State responsible for Finance, Mohammed Amin Adam stated that the Fund will likely approve the first tranche of a \$600 million loan for Ghana by Wednesday, May 17, 2023.

The Minister said the government expects the IMF Executive Board to approve the credit facility after meeting all pre-conditions and requirements particularly after financing assurances have been granted by official creditors, China and the Paris Club.

"We expect a deal on Wednesday. With the disbursement, there is going to be \$600 million as a first tranche just immediately after the approval," he told Reuters via phone. Even before the first tranche is approved and thus arrives today, some economists

and analysts have questioned the possibility of Ghana to receive the first tranche of the \$3 billion from the International Monetary Fund today (Wednesday) or this week as stated by the government. IEA's Dr. John Kwakye is of the strong opinion that his checks conducted on the IMF Board meeting schedule do not show that Ghana will be meeting the Board even by May 24.

On Monday, May 15, 2023, he wrote on Twitter "My check on

on Monday, May 15, 2023, he wrote on Twitter, "My check on IMF Board Meeting Schedule for the coming week shows the following: May 17, Benin; May 22, Indonesia; May 24, Cote d'Ivoire; May 25, Mali. So where is Ghana? Unless somebody is seeing a different schedule. Please share it if you are."

On the same tangent, Vice
President of policy think tank
IMANI Africa, Bright Simons noted
that the government must be
cautious as it seems to be
overplaying its cards and
stampeding the technical
processes of the IMF.
He wrote: "Ghana is back to its

usual mode of stampeding technical work at the IMF. It has announced Board approval & release of \$600m next week when significant work remains ongoing as to the precise details & timing of tranches etc. Ghana risks overplaying the political cards it holds"

He also added that "It is not clear why the politicians feel the need to do this. It is very unusual behavior. Every sophisticated investor knows that whilst the full commencement of the IMF program is an important milestone it is not itself a turning point. The govt should keep its eye on the ball."

On the other hand, Dr Amin Adam was however optimistic that the funds will be disbursed into the Bank of Ghana account within a week of the IMF Board's approval. Speaking on the second tranche of the \$600 million loan, the minister of State said the government expects the funds to also hit the Central Bank's account in November or December after a successful review of the first loan tranche under the programme.



Dr Amin Adam added that the rest of the funds will be disbursed in equal tranches of \$360 million after the IMF has conducted its semi-annual reviews of the extended credit facility.

"The funds will boost Ghana's coffers and help it work towards the target of foreign reserves amounting to the equivalent of three months of imports by 2026," the minister of State told Reuters.

Erdoğan Upsets Opposition Hopes Of Victory, Run-Off With Kılıçdaroğlu Expected In Turkey's Presidential Race

n the Turkish parliamentary elections held on Sunday, May 14, the ruling Justice and Development Party (AKP)-led People's Alliance retained its majority. However, there was no clear winner in the presidential elections and a run-off is likely to be held between incumbent Recep Tayyib Erdoğan and his challenger Kemal Kılırdaroğlu.

As per Turkey's Supreme Election Council (YSK), over 87.20% of the electorate or 55 million citizens voted in the elections. The results have defied <u>public opinion surveys</u>
published prior to the vote which
stated that Kılıçdaroğlu was ahead
of Erdoğan. Kılıçdaroğlu was
expected to also benefit from the
withdrawal of Muharrem ince, one
of the four presidential candidates.
The results have also dashed the
opposition's hope of benefiting
from the serious popular grievances
against Ergodan's government,
which include prolonged high
inflation deepening the cost of living

crisis, the issue of Syrian refugees, and the mismanagement of the February earthquake relief.

Meanwhile, several opposition leaders have accused state broadcaster Anadolu Agency (AA) of misrepresenting and manipulating the presentation of the results.

Presidential race

For the post of president, a run-off will most likely be held two weeks from now as neither of the lead candidates were able to secure 50%+1 votes after counting of over 99% votes.

Erdoğan emerged as the front runner with over 49.4% votes. He was contesting the election on the agenda of continuing his economic and foreign policies. Kemal Kılıçdaroğlu, the joint candidate of the Nation Alliance led by the Republican People's Party (CHP), who was leading in the preelection surveys, failed to win even 45% of the votes. He was contesting on the agenda of

<u>"change"</u> which included going back to the parliamentary system as well as radical changes in foreign policy with a pro-Western approach.

Erdoğan's government had brought a constitutional amendment in 2017, which was approved by a referendum, converting the country's parliamentary system of governance into a presidential one.

The third presidential candidate, Sinan Oğan, won over 5% of the votes, which surprised many election observers. Oğan is a former member of the Nationalist Movement Party (MHP) and was the candidate of the far-right ATA alliance.

The fourth candidate, Muharrum ince, had withdrawn from the contest days before the vote, claiming a smear campaign against him by his former party (CHP) colleagues.

Parliamentary election results
In the parliamentary elections, the

incumbent People's Alliance led by the AKP secured a majority with close to 50% of all votes and 321 seats in the 600-seat parliament. The alliance however lost around 3% votes and 23 seats compared to the last elections

As per the results, the AKP alone will have 266 seats. It had 295 seats in the last parliament. Its alliance partner MHP won 50 seats and another ally five seats.

The opposition alliance won 213 seats—the CHP winning 169 and the iYi or Good Party winning 44 seats. The alliance obtained around 35% of the votes and saw a significant increase in seats, but could not reach the halfway mark.

The Labour and Freedom Alliance led by the leftist People's Democratic Party (HDP) won 66 seats, with the HDP alone securing 62 seats and Turkish Workers' Party (TiP) winning four. It obtained around 10% of the total votes.

The HDP was contesting the election under the banner Green Left Party (YSP) in order to avoid potential

Bail For Imran Khan Sparks Protests By Ruling Coalition In Pakistan

n Monday, May 15, activists of the Pakistan Muslim League (Nawaz), Pakistan Peoples' Party (PPP), and Jamiat Ulema-i-Islam-Fazl (JUI-F)—that together form the ruling Pakistan Democratic Movement (PDM)—staged a sit-in protest outside the Supreme Court in Islamabad against its ruling granting relief to former Prime Minister Imran Khan after his arrest last week. The sit-in was attended by PMI-N's senior leader Maryam Nawaz and JUI-F chief Maulana Fazlur Rahman. Members of the ruling coalition led by Prime Minister Shehbaz Sharif had raised concerns about "double

standards of the judiciary" and announced protests against the Supreme Court's decision to grant Khan relief on Friday, May 12. On Friday, Khan was granted protective bail for two weeks by the Islamabad High Court in a number of cases, including the Al Qadir Trust case under which he was <u>arrested</u>on May 9. Khan's bail followed the Supreme Court ruling his arrest to be "invalid and unlawful" on Thursday, May 11. The court said it took up the case as "the right to access to justice was denied (to Khan) and the sanctity and safety of the high court were violated."

Khan's arrest was the culmination of a long tussle with the civilian and military establishment ever since he was forced to guit after a noconfidence motion in 2022. Imran had alleged that his overthrow was orchestrated by the military, claiming that his independent foreign policy was among the reasons. In the subsequent months, his popularity surged even as the PDM government, which comprises Pakistan's traditional ruling parties, failed miserably in dealing with the economic issues faced by the people. Following Khan's arrest, violent protests by supporters of his Pakistan Tehreek-e-Insaf (PTI) party erupted

across the country. Several vehicles were set on fire and state-owned buildings were attacked. The Punjab police reportedly arrested 3,500 people in a crackdown against PTI workers.

Following his bail, Khan alleged that at least 7,000 PTI activists, including several women, had been jailed while "security authorities are busy facilitating thugs take over the Supreme Court." On Monday, Khan called on his supporters to offer funeral prayers to the "martyrs" who had lost their lives during the

China Issues Report On U.S. CIA's Cyberattacks On Other Countries

hina on Thursday released an investigation report revealing an "empire of hackers" of the Central Intelligence Agency (CIA) of the United States, one of the major intelligence agencies of the country's federal government. Over a long period, the CIA has been secretly orchestrating "peaceful evolution" and "color revolutions" around the world, continuously conducting espionage activities, said the joint report by China's National **Computer Virus Emergency** Response Center and Beijingbased internet Security Company

The report disclosed important details of the weapons the CIA used for cyberattacks and details of specific cybersecurity cases

taking place in China and other countries.

The CIA has been involved in overthrowing or attempting to overthrow more than 50 legal governments of other countries, though it only admitted involvement in seven, causing turmoil in relevant countries, the report said.

Cyberspace hegemony

In 2020, the 360 company discovered an unknown cyberattack organization, which carried out a slew of cyberattacks toward China and other countries by utilizing cyber tools related to "Vault 7" - a series of documents that WikiLeaks began to publish in 2017 to expose the CIA's activities and capabilities in

electronic surveillance and cyber warfare.

Such cyberattacks can be traced back to the year 2011, and continue to this day. The targets of such espionage actions expand to fields such as countries' key information infrastructure, the aerospace sector, scientific research institutes, the petroleum industry and tech companies, as well as government agencies. The CIA has complicated inner workings. By the end of 2016, there were already over 5,000 hackers in the CIA's hacking division - Center for Cyber Intelligence, producing more than a thousand hacking systems, Trojans, viruses and other "weaponized" malware, according to WikiLeaks. Yuyuan Tantian, a



social media account affiliated with China Media Group, commented that the complexity of the organizational structure enables the CIA to tailor different tools to steal information.

For example, the agency divulged users' secrets through smart TVs with their attack toolkit, Weeping Angel, developed by the Embedded Devices Branch. The toolkit can make TVs "pretend" to be switched off but in fact, they are still overhearing. The report also noted that the Chinese technical team obtained a sample of an information interception tool that is exclusively used by the

Since 2015, the CIA massively

has taken advantage of zeroday vulnerabilities in its global cyberattacks, setting up "zombie botnets" and "stepping stones" around the world to launch attacks on network servers, network terminals. exchangers and routers, as well as a huge amount of industrial control equipment, according

to the report. In the joint investigation, the team captured a plethora of malware such as Trojan programs and plug-ins related to the CIA. All the cyberattacking weapons were strictly standardized, processed and underwent professional software engineering management, and only the CIA abides by these standards and specifications to develop cyberattack weapons. The investigation also found that the CIA's cyberattacks cover all networks, which enables the agency to easily steal sensitive data of other countries at any time. (With input from Xinhua)

"Regardless of the circumstances surrounding the electioneering process and the outcome of the election itself, we must not all join the rescue mission of liberating our mother Ghana from the


modern-day imperialism and colonialism practiced in a benevolent democracy under this NPP government," the statement said.

Police Invites Frimpong-Boateng Over Galamsey Report

he police service has written to Prof Kwabena Frimpong-Boateng as it opens an investigation into his 37-page galamsey report, from which a docket is to be built for prosecution.

This was revealed by Attorney General Godfred Dame.

He said that the docket would eventually get to his office for the already-started due process to continue, thus, debunking perceptions that he has removed himself from the matter.

Prof Frimpong-Boateng, who chaired the Inter-Ministerial Committee on Illegal Mining, accused some government officials and appointees of the president at the Jubilee House, of not only engaging in galamsey

but also frustrating his fight against it while in office as the Minister of Environment, Science, Technology and innovation.

He named the director of operations at the presidency, Mr. Lord Commey, as one of the bigshots behind galamsey in the country.

The world-renowned heart surgeon also accused the president's cousin, Mr. Gabby Asare Otchere-Darko, of intervening to frustrate attempts by the committee to stop Imperial Heritage Limited from decimating some forest reserves through illegal mining activities. Prof Frimpong-Boateng also said Information Minister Kojo Oppong Nkrumah, orchestrated media attacks on him so as to court disaffection against him in

the eyes of President Nana
Akufo-Addo as far as his fight
against galamsey was concerned.
Additionally, Professor FrimpongBoateng named Mr. Joseph
Albert Quarm, a former Member
of Parliament for Manso
Nkwanta, as being neck-deep in
illegal mining.

They have all denied the allegations.

Speaking on the matter, the Attorney General said, although he is interested in the report, he wants due process to be gone through without him being seen as "railroading" it.

"I am interested in it, but of course, certain fora have been invoked: I understand CHRAJ sees of it, the OSP sees of it. If now I, as Attorney General were to review the report, what would you think? I'm sure it will lend

itself to all kinds of suspicions," he told Kojo Yankson.

"I think that really, I can look at the report and review it, but if I do so, you the same media, will say: 'He's just a government's lawyer.' Yes, let independent people look at it," Mr. Dame stated.

He said since the docket would eventually land on his table, his intervention is not needed now. "So, really, I've not removed myself from the process, I'm part of it. It's just due process that will have to be followed".

He advised the media against sanctifying the report prematurely. "But a caution and admonition that I would like to give you, the media is that do not raise the level of it and do not accord any sanctity to the report until it has gone through the test prescribed by law."

Gold Mafia Exposé: South Africa Opens Criminal Probe Into Al Jazeera Documentary

financial impropriety using
the country's banking

system.

The four-part documentary titled 'Gold Mafia' entailed a number of rogue businessmen who spoke about an extensive money laundering and gold racketeering business across a number of African countries.

Ramaphosa, responding to a question in Parliament said, the government took the allegations very seriously and that even though no arrests have been made, a formal probe had commenced.

"The government takes the allegations made in the Al

Jazeera documentary titled Gold Mafia very seriously. We are committed to preserving the integrity of our financial system in the interest of the broader economy and ordinary citizens. "With respect to actions currently being taken to investigate individuals who are alleged in the documentary to be criminally implicated an inquiry has been registered to investigate these syndicate and individuals," he stated. He said no arrests had been made at the time he was speaking but that, "details of steps cannot be divulged," as the financial action taskforce investigates with the view to prosecute and prevent financial activities as were captured in the film. Ghana was also mentioned in

one sequel of the film, with Alistair Mathias a self-confessed money launderer stating among others that he was friends with president Nana Addo Dankwa Akufo-Addo who was a lawyer of his at a point.

The president told Al Jazeera that he had no recollection of dealing with Mathias before his lawyer also denied that he acted at a point for Mathias or his company. Alistair himself denied knowing Akufo-Addo. After the documentary was aired, government wrote to Al Jazeera demanding a retraction and apology for some parts of their reportage but the Dohabased channel said it owed the president no apology because it had done due diligence in telling both sides of the story.

Government To Borrow GH¢2.73 Billion From Treasury Bills This Week

overnment is seeking to borrow GH¢2.732 billion from treasury bills auction on May 19, 2023.

The target is expected to be generated from the 91, 182, and 364-day treasury bills.

This week, the government secured GH¢2.78 billion from the sale of treasury bills in its latest auction on May 15, 2023.

The target for the auction was GH¢3.33 billion.

Even though this was a bit higher than what the government got last week, it was GH¢550 million short of the target.

Interest rates have also slightly increased to an average of

between 20.43 percent to 27.59 percent.

According to the auction results from the Central Bank, the government secured GH¢2.31 billion from the 91-day bill, GH¢355.26 million from the 182-day bill, and GH¢115.60 million from the 364-day bill.

Interest rates, however, increased from 20.25 percent to 20.43 for 91-day bills from 22.82 percent to 22.96 percent for the 182-day bill, and from 27.36 percent to 27.59 percent for the 364-day bill.

However, the Minister of State responsible for Finance, Mohammed Amin Adam has disclosed that the International Monetary Fund will likely approve the first tranche of a \$600 million loan for Ghana by Wednesday, May 17, 2023.

According to him, the government expects the IMF Executive Board to approve the credit facility after meeting all preconditions and requirements particularly after financing assurances have been granted by official creditors, China and the Paris Club.

"We expect a deal on Wednesday. With the disbursement, there is going to be \$600 million as a first tranche just immediately after the approval," he told Reuters via phone.

Dr Amin Adam was however optimistic that the

funds will be disbursed into the Bank of Ghana account within a week of the IMF Board's approval.

Still No Justice, A Year Since Shireen Abu Akleh's Killing



Palestinian-American journalist Shireen Abu Akleh was killed by Israeli forces in May last year while covering a raid in a refugee camp in Jenin. The senior Al-Jazeera journalist was killed and her colleagues also attacked while they were covering an Israeli army raid on a refugee camp in Jenin in the occupied West Bank

year has passed since senior journalist Shireen Abu Akleh was killed by the Israeli security forces, but the fight for justice continues as no one has been held accountable for the crime yet. Justice in Akleh's case is significant both for freedom of the press in the occupied Palestinian territories and for ending Israeli impunity in crimes against Palestinians.

Shireen and her colleagues were covering a raid by the occupying Israeli forces on a refugee camp in Jenin in the northern occupied West Bank when they were attacked. Akleh was shot in the head and her colleague Ali al-Samoudi was injured in the attack but later recovered. Both were fired upon despite wearing press vests, clearly

identifying them as journalists. Immediately after she was killed, Israeli officials claimed that she was killed by Palestinian fighters during crossfire with Israeli forces. However, Israel was quickly forced to retract the claim after Israeli human rights group B'Tselem published an investigative video debunking it. On May 20, 2022 they announced that Israeli military police criminal investigation division would not investigate the killing of Palestinian journalist Shireen Abu Akleh, reportedly over fears that the investigation may demoralize the Israeli army which operates "under caution" and create controversy in Israeli society. In September 2022, Israel finally

admitted that she may have died in accidental fire caused by an Israeli soldier, but refused to holdanyone accountable. Meanwhile numerous independent investigations by international and Palestinian human rights organizations were carried out which established that Akleh was unequivocally targeted by the Israeli forces and that her killing was intentional. During her funeral procession in the occupied West Bank held days after her murder, Israeli forces attacked mourners and charged at people who were carrying her coffin, almost making it fall to the ground. No one has been charged for this attack either.

Akleh's family, her colleagues, and the world community are still hoping that Israel will be held accountable for these crimes. On Sunday, May 7, her niece Lina Abu Akleh told Al-Jazeera during a memorial mass that they are "still fighting for justice."

killed by Israeli forces in the last two decades, and at least 16 others have been jailed.

Despite Akleh being a US citizen, the US government has been reluctant to intervene in any meaningful way to seek justice in her case. It initially almost gave a clean chit to Israel by blindly relying on its version of Akleh's death being accidental. Her family responded by saying that the US was "insulting" her memory.

Only after pressure from Akleh's family, her colleagues, and others, the Biden administration in the US was forced to constitute an FBI inquiry in November, almost seven months after her killing. That investigation is also dragging, with no public information of any progress made so far.

Israel has already refused to cooperate with the inquiry.
Then-Israeli Defense Minister
Benny Gantz had called the US decision to constitute an FBI inquiry "a grave mistake" constituting external intervention in Israel's domestic affairs.
In fact, Israel has never held its

security forces accountable for killing journalists in the occupied territories. Even if an investigation was carried out, there was no guarantee that anyone would ever be punished. As Israeli human rights group B'Tselem said, "no one should expect that they [Israel] will deliver justice to Palestinians." The group also stated that instead of carrying out a meaningful investigation, Israel only whitewashes the crimes of its armed forces.

In a <u>report</u> issued just before the anniversary of Akleh's killing, the New York-based Committee to Protect Journalists (CPJ) confirmed the claims made by B'Tselem. According to its report, Israeli armed forces have killed at least 20 journalists inside the occupied Palestinian territories since 2001, including Akleh, but till date no investigation has held a single Israeli responsible for any of those killings.

'Aklehs family, the Palestinian Authority, Al-Jazeera, and others have formally requested for or backed an International Criminal Court (ICC) investigation into her killing.

Youth Sub-Platform On SDGS Call For Stringent Action On Epidemic Financing

he Youth Sub-Platform on the Sustainable Development Goals (SDGs) has added its voice to the call by 567 people and Civil Society Organizations who signed a petition to get the Government of Ghana to establish a Public Health Emergency Fund in line with the National Action Plan for Health Security (NAPHS).

A statement issued from the platform said with Ghana faced with unprecedented crisis during the COVID-19

pandemic, there is a need for mitigation strategies including the establishment of the <u>COVID-19</u> Fund put in place to address the havoc caused by <u>COVID-19</u>.

"Though the mitigation measures contributed to controlling the spread of COVID-19 to some extent, it is worth noting that kneejerk responses to disease outbreaks have high consequences for a country's economy and could lead to high mortality rates.

It continued, "As a country, our experience in the wake of <u>COVID-19</u> should guide us to implement and expand on the implementation of the NAPHS by establishing a Public Health Emergency Fund (PHEF) to rope in the needed investments for Epidemic Preparedness Financing and Response (EPFR)."

"Truth be told, public health emergencies are unforeseeable. No one knows when the next pandemic will hit us again, but we can insulate ourselves from its debilitating effects by adequately preparing by establishing a Public Health Emergency Fund. With such a fund in place, we shall overcome threats posed by any pandemic," the statement noted.

The Ghana SDGs Youth Sub-Platform further called on President Nana Addo Dankwa Akufo-Addo, the Ministries of Finance, Health and other relevant stakeholders to take collective actions in ensuring



that the Public Health Emergency Fund is established to mitigate the adverse effects of disease outbreaks.
