SUMMONS TO APPEAR BEFORE THE COMMISSION RE: NOTICE OF INDUSTRIAL ACTION

The National Labour Commission's attention has been drawn to a press statement issued by the leadership of Korle-Bu Doctors Association (KODA) in which the Association threatened to embark on industrial action effective **2nd May, 2026**.

In the said release, the Association raised issues of patient safety, professional integrity and the long-term effectiveness of the institution as the issues in dispute.

The said notice was not in compliance with Section 162 of the Labour Act, (2003), Act 651; that notwithstanding, the National Labour Commission, in exercise of its powers under section 139 of Act 651, writes to summon the parties to appear before the Commission on **Thursday, 7th May, 2026 at 1:30 pm for a hearing of the issues in dispute.**

With this intervention, the Association is advised to stay the intended action(s) and appear as scheduled.
